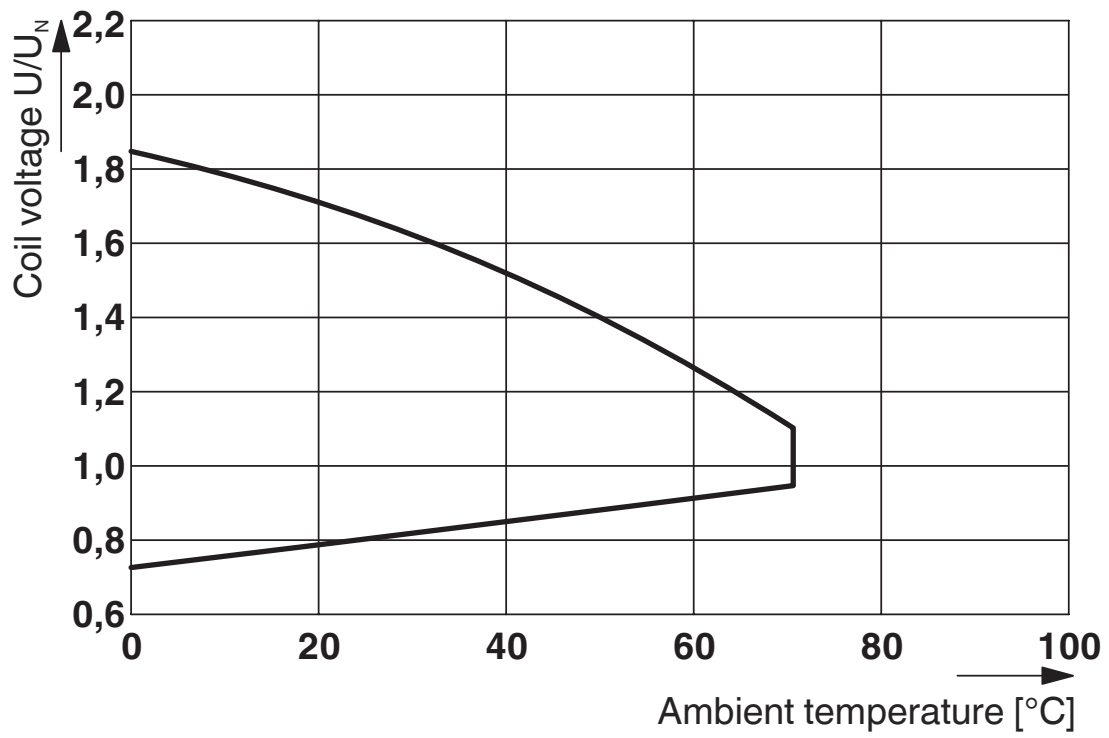

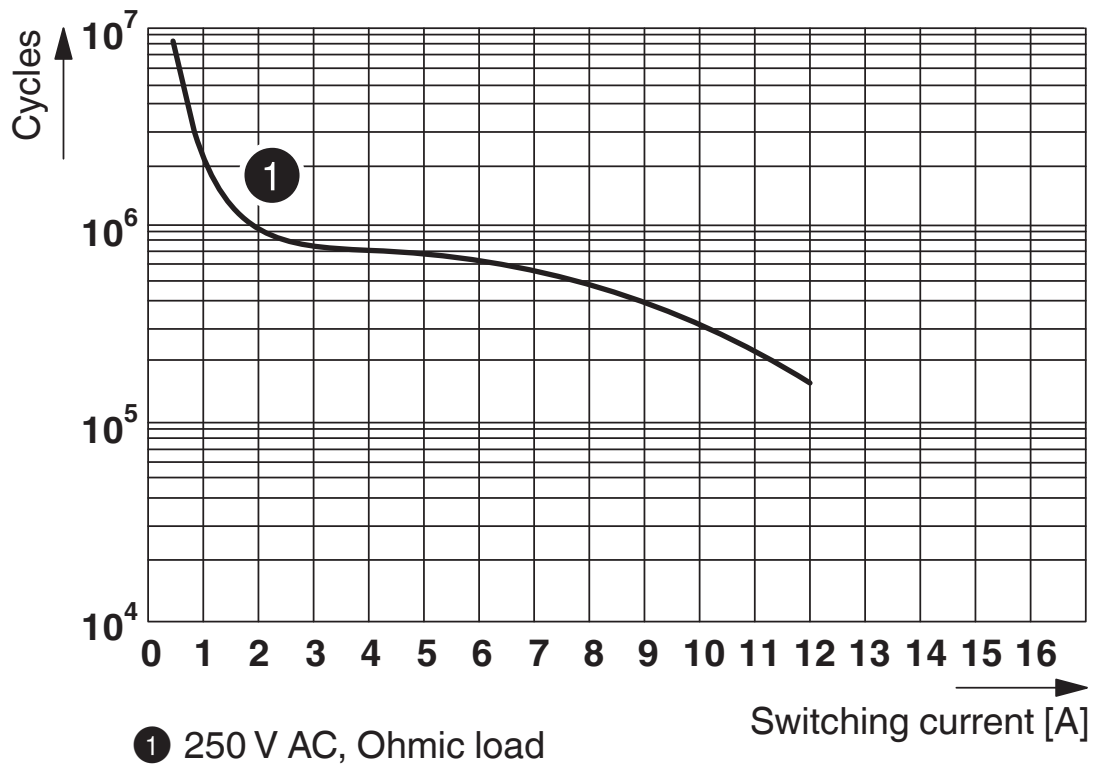

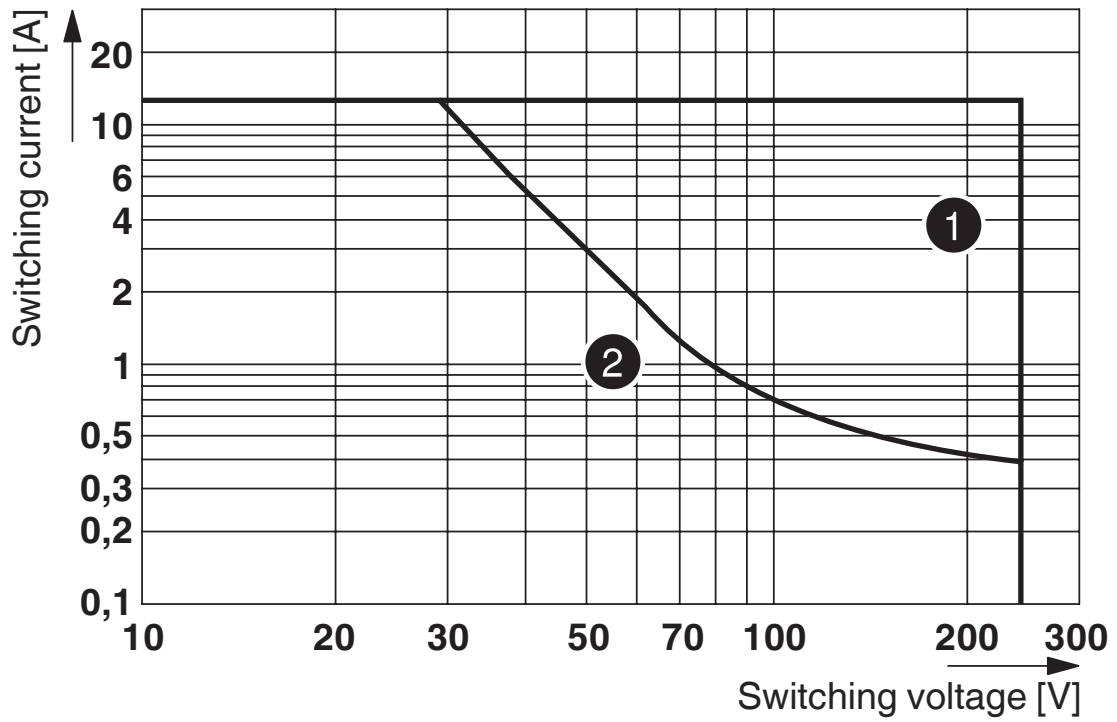
Operating voltage range

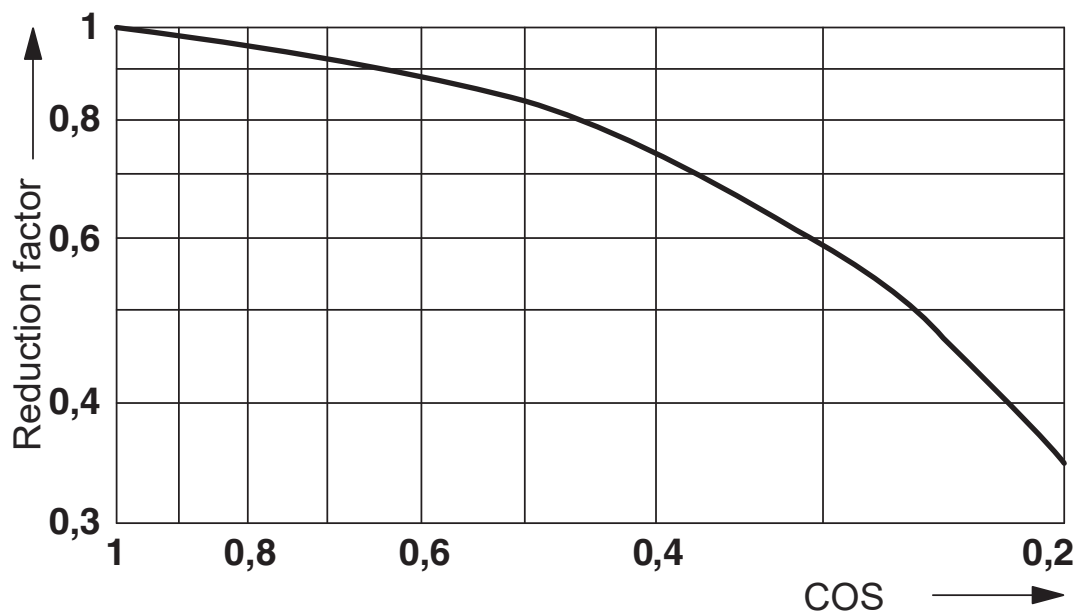

- ② DC, ohmic load

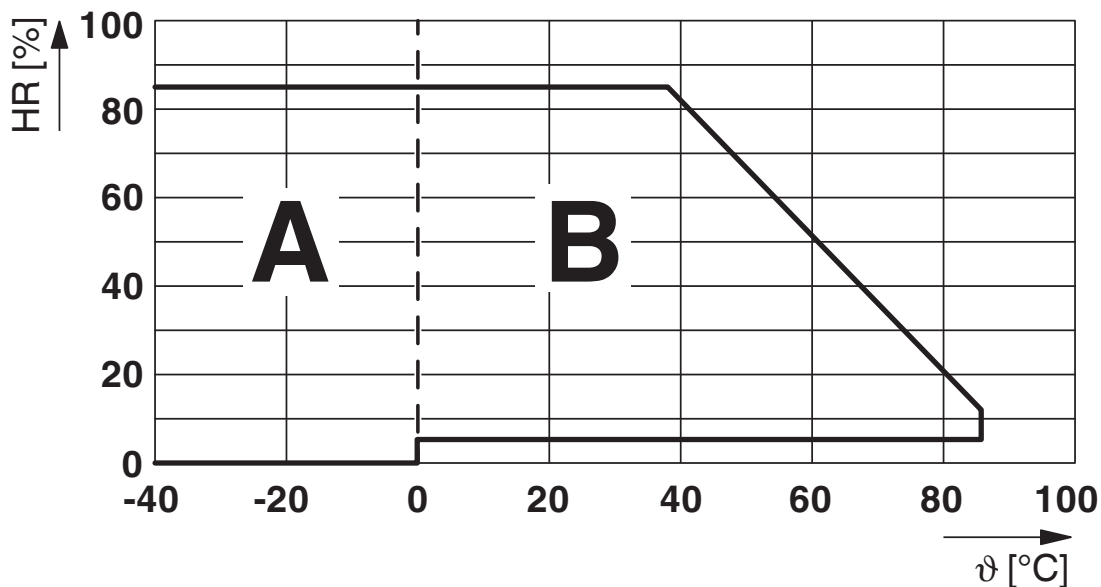
Interrupting rating

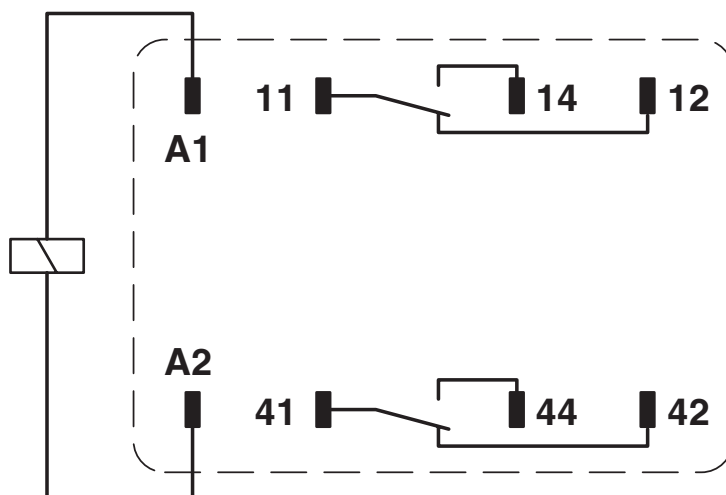
