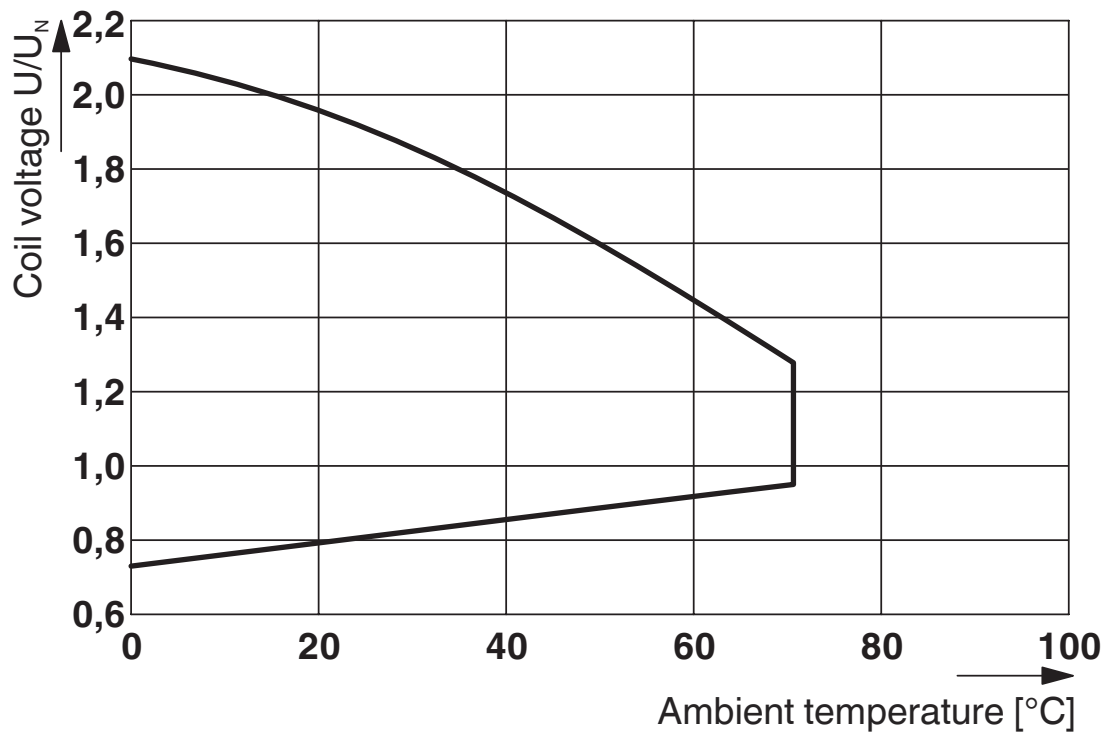

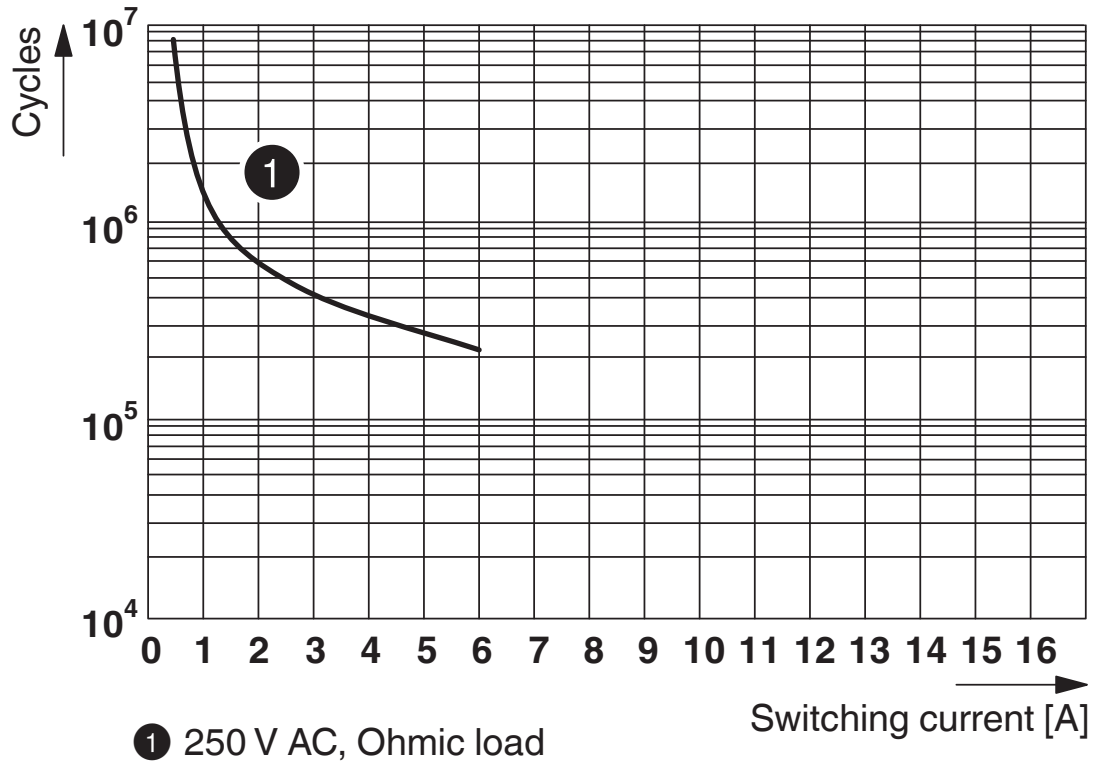

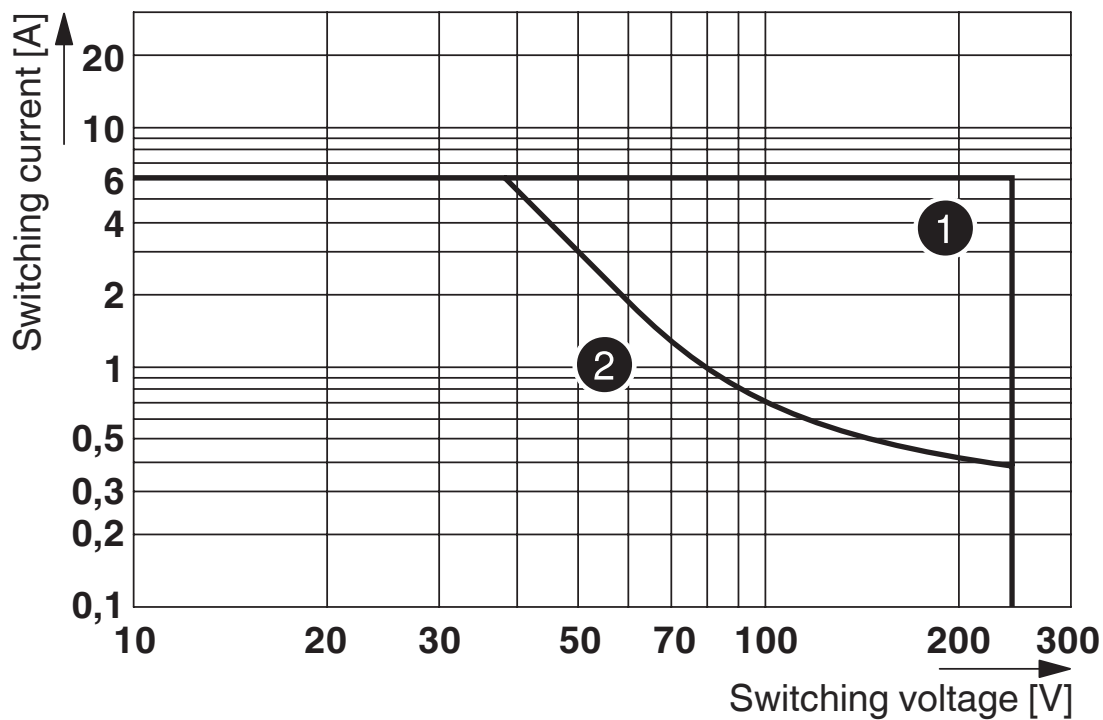
Operating voltage range
