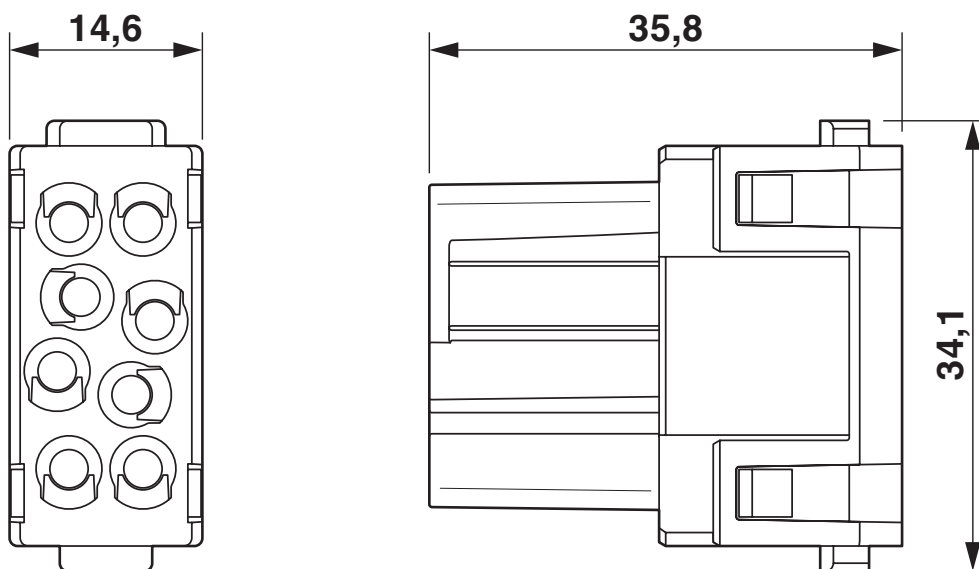

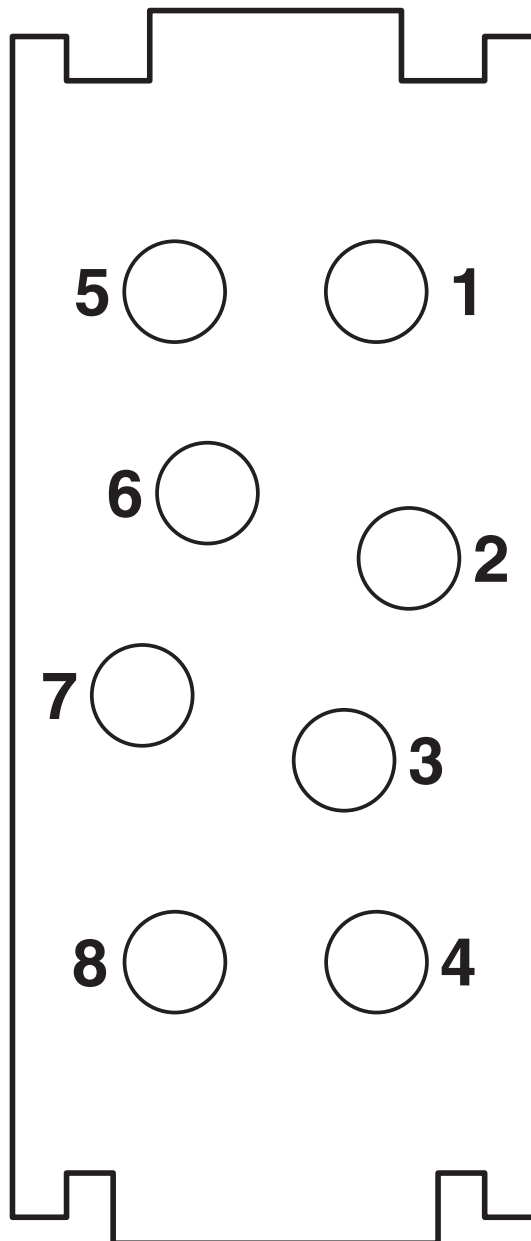

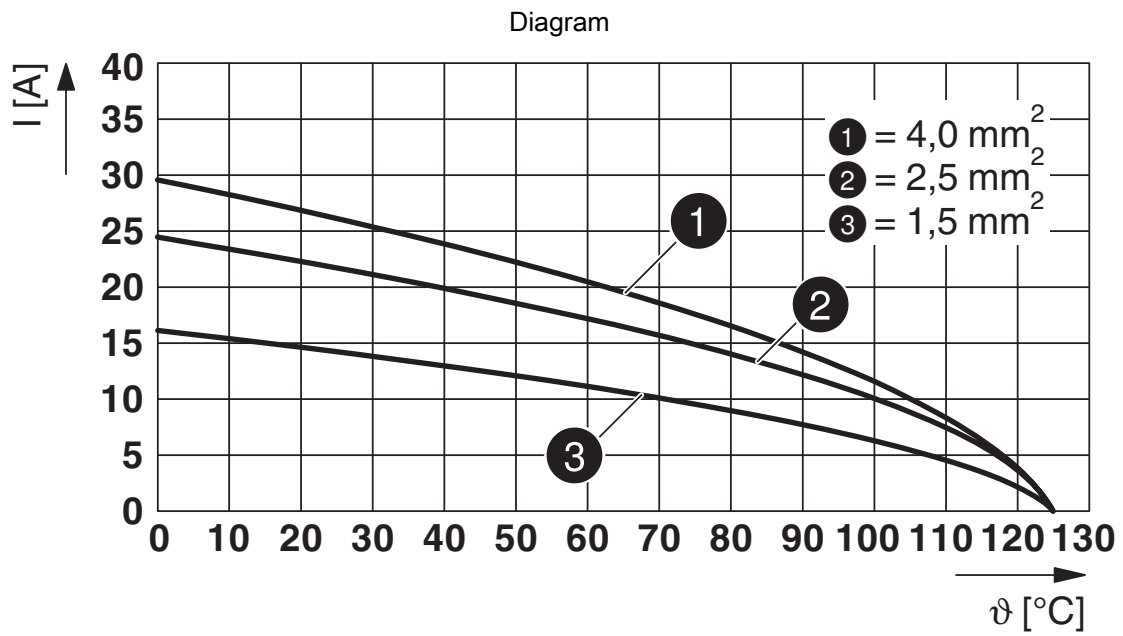
Schematic diagram
